# Transitioning from the Use of Adult Parole Authority Staff to Provide Probation Services to Common Pleas Courts

The state budget bill (HB 166) provided funding to allow the Department of Rehabilitation and Correction (DRC) to remove their Adult Parole Authority (APA) staff support to county common pleas court probation departments and offer the county grant funding to replace the services being provided by APA staff. DRC has been providing APA staff to assist with the supervision of county common pleas court probation cases. In twenty-three counties the APA staff augments the probation department's staff, however, nineteen counties do not have a probation department and the APA staff is providing all probation services. The panel will discuss the current status of the transition planning and elements of the grant funding being provided and the future for common pleas probation departments operating without APA assistance.
